

Application for divergent examination method(s)

Information about the process

If special rules are to be observed within the study or training course, these must be respected.

In case of rejection:

- Information to the applicant via e-mail.
- The applicant receives the signed application back and the application is automatically forwarded to the Disability Representative at the relevant campus.
- The applicant may appeal against the rejection to the academic council of the FH Upper Austria.

Should the circumstances change, and the deviating examination methods granted therefore need to be changed, a new application must be submitted with the requested changes and, if necessary, more recent evidence as a basis.
